# QA of Micro-credentials

---

- Report 'Approaches to Quality Assurance of Micro-credentials' -> Published in August 2023
- Reflective questions for internal and external QA of Micro-credentials-> Published in January 2023
- Data standard for information on Micro-credentials -> is defined
- Inclusion of micro-credentials and alternative providers in DEQAR - Message to the 2024 Bologna Process Ministerial Conference -> finalised in May 2024
- **Feasibility study for a quality label for Micro-credentials -> ongoing**
- **Last meeting of the WG -> 18/09/2024 (Online)**
