#### Staff mobility within the TPG-LRC CoRE project

- TPG B participants will have the opportunity to offer or receive peer support on the topic of recognition and implementation of the LRC through staff mobility, starting from the 6 specific thematic indications for TPG B.
- Mobile staff members will be able to deepen their topics of interest through structured peer learning activity, to match their offers and needs.





#### **Functioning**

- Maximum 20 participants for 5 days each.
- Every member of TPG B can apply to send 1 member only. Additional members on a self-paying basis.
- At the end of the period abroad, each mobile staff member will be asked to write a report.





#### **Application**

To express interest in the staff mobility, send an e-mail answering to 3 questions:

- Is your organization willing to offer or to receive peer support?
- What is the specific thematic indication you are interested in and why?
- Do you have a prior agreement with an institution to organise the staff mobility?

A committee composed of the three co-chairs of the TPG B will review the applications and match the staff members (for thematic interest and geographical spread).





#### Financing/1

- Financing is limited to maximum 5 days.
- Travel and subsistence costs will be covered by the project and reimbursed in unit costs, according to the EU funding rules:
- For travel cost, 200 € per flight (return journey) will be reimbursed.
- Subsistence and accommodation costs provided as an amount of 210 € per night spent in the hosting country (up to a maximum of 5 nights).





#### Financing/2

- It is possible to transfer subsistence and accommodation costs to travel costs provided that the total amount reimbursed for the staff mobility does not exceed 1250 €.
- Staff mobility costs will be reimbursed upon submission of relevant supporting documents:
  - Boarding pass.
  - Travelsheet.
  - Report on the peer learning activity outcomes





#### **Timing**

- Launch of the call for applications: March 2023
- Deadline for applications: 31 May 2023 (an application form will be provided after the 5th TPG B meeting)
- Matchmaking committee to match the applications: 16 June 2023
- Announcement of selection results: 19 June 2023
- Staff mobility: from July 2023 to 31 January 2024
- Deadline Report on the peer learning activity outcomes: 1 month after the end of the mobility at the latest.





#### Matchmaking activity - 5th TPG B on LRC/1

- **Identify specific topics** on which they are willing to receive or to offer peer support starting from the 6 <u>specific thematic indications</u> for TPG B
- A first attempt to create a preliminary pairing among TPG B members
- For the consultative members, the idea is that they can offer support.
- Timing: 1 hour





#### Matchmaking activity during the 5th TPG B on LRC/2

- Participants will be provided with two cards in different colours: "what can I share?" "what would I like to deepen?" On each card, participants will write (15 minutes):
  - Country
  - Number of the specific thematic indication/s
  - Topics that you want to deepen





#### Matchmaking activity during the 5th TPG B on LRC/3

- Participants will be asked to go around the tables to discuss together on what is written on the cards, trying to pair themselves (20 minutes)
- On the posters, participants will start attaching the cards according to the pairing decided together (15 minutes).
- Announcement of the matches (10 minutes)
