





### **Statistics**



- ■More than 2 mln refugees after 24 February 2022
  - >population growth 5% in the first 3-4 weeks
- □ Demographic profile of refugees
  - >more than 90% women and childred
  - ➤ approx. 200 000 children admitted to Polish schools, approx. 500 000 learning on-line (Ukrainian programmes) (Data 30.04.2022)
- □Students (also Polish students) at Ukrainian HEIs (approx. 1 500 000)
- ☐Growing number of applications for recognition of Ukrainian qualifications (growth of more than 300% compared with 2021)
- □ Applications with incomplete documentation

## Legal solutions

- The stay of a Ukrainian citizen who entered the territory of Poland from 24.02.2022 is considered legal for a period of 18 months from this date.
- ■Employment of teachers
  - classes for Ukrainian children (non-speaking Polish)
  - supporting teachers (Polish speaking)
- □ Employment of medical staff
  - temporary access to profession (18 months from 24.02.2022)
  - in clinics providing medical services for Ukrainian cictizes (non-speaking Polish)
- ☐ Emloyment of psychologists
  - degree in psychology (long-cycle or first cycle + second cycle)
  - > provision of psychological services for Ukrainian citizens
- **□**Employment of academic teachers and researchers

# Legal solutions



- □ Recognition of qualifications
  - > special procedure for persons with missing documentation
- □ Recognition of periods of study (foreigners and Polish citizens)
  - > Special procedure for those with partial documentation or no documentation
  - > since 24.02. 2022 (Data 10.05.2022):
    - > approx. 6 000 Ukrainian students contacted Polish HEIs
    - more than 400 admitted students
    - > more 800 students in the admission proces
