# 428 DAYS OF **WAR** IN UKRAINE

over 3198 education facilities have been damaged, 286 destroyed completely by shelling  
over 8 million of externally displaced Ukrainians  
approx. 7 million of internally displaced people  
461 children died, more than 927 were injured

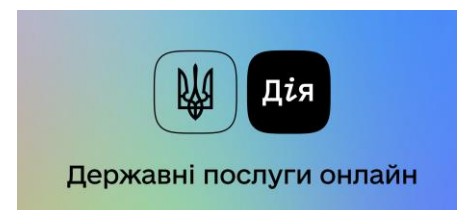

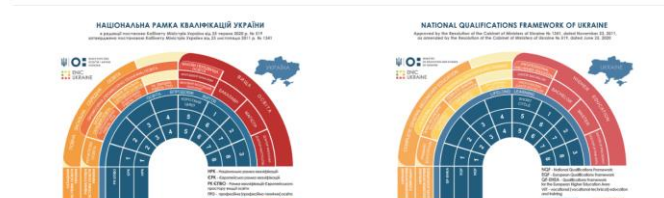
