ToR of the BICG

- **Members of the BICG 2024-27:** Albania, Azerbaijan, Bulgaria, EUA, European Commission, ESU, Finland, France, Georgia, Italy and the TPG co-chairs (with usually only one co-chair of each TPG attending the meeting of the BICG)

Key tasks of the BICG as by ToR

- **Coordinate and support** the work of the TPGs;
- **Identify synergies** in the work of the Thematic Peer Groups: consistence and coherence of outcomes;
- **Keep an overview** of the composition and activities of the different groups;
- Seek to **improve the Peer Support Approach** if and as needed;
- Give the BFUG **regular updates and an overview on the progress** and effectiveness of the Peer Support Approach, based on the activities of the TPGs;
- Prepare **recommendations for further actions** to improve implementation (to BFUG)
- Prepare a template for **national action plans** on implementation of Tirana commitments
- **Ensure synergies** between the national plans and the activities of the TPGs

Operation

- **2 meetings/year**, ideally 2-3 weeks prior to the BFUG Board meetings
- physical or online, taking into account the availability of the BICG members
- reports to the BFUG Board and at least once a year to the BFUG

February 2025, online

May- June 2025, online

- Updates from the TPGs
- Discussion about National action plans and their impact on the work of the TPGs
- Follow-up on key common topics

October 2025, online

- Updates from the TPGs
- Follow up on key common topics
- Preparation of possible BFUG thematic discussion on implementation

First BICG meeting, 4th Feb (online)

- Workplan of the BICG, including timing and topics of meetings
- Draft activity plans of the TPGs
- Clarifying communication channels and reporting requirements between the TPGs, BICG and BFUG (incl. the BFUG Board)
- Encouraging:
 - focus on implementation of commitments (projects in the service of TPGs)
 - reduction of sub-groups
 - synergies between TPGs
 - communication between countries BFUG and TPG representatives

- **TPG A: Qualifications Frameworks**
 - France, Georgia, Latvia
- **TPG B: Lisbon Recognition Convention**
 - France, Italy, Ukraine
- **TPG C: Quality Assurance**
 - Armenia, France, Romania
- **TPG D: Social Dimension**
 - ESU, Latvia, Malta

Key topics of TPGs

- TPG A:
 - Successful implementation of self-certification process;
 - QFs to support recognition of transnational education and joint programmes;
 - NQF and openness to study programmes outside of the Bologna three-cycle structure/
QF and flexible learning
 - Databases and registers of qualifications reflecting QFs
 - QF and automatic recognition
- TPG B:
 - Optimizing the potential of digital technology;
 - Recognition of alternative pathways.
 - Achieving automatic recognition.
 - Roles and responsibilities in carrying out recognition procedures.
 - Ensuring fair recognition of qualifications held by refugees.
 - Legal frameworks for implementation of the LRC (Global and regional conventions)

Key topics of TPGs – cont.

- TPG C:
 - Addressing ESG implementation gaps through thematic analysis
 - International quality assurance (QA): Cross-border QA, QA of transnational education and implementation of the European Approach for QA of Joint Programmes
 - Innovative QA practices: QA of flexible learning pathways, European University Alliances and promotion of a quality culture
- TPG D:
 - Building practices for the new TPG
 - Implementation of the PAGs, starting with social dimension related policies and strategies → framework and toolkit creation to support national implementation
 - Voluntary country reviews
 - Research and data analysis
 - Online peer-learning activities

Key topics of TPGs – cont.

For all TPGs:

- Planned activities include e.g. PLAs, staff exchanges, mapping of good practice, and policy discussions on the implementation of the commitments
- Some activities depend on project funding (e.g. online vs. in person etc)
- Draft activity plans build on previous work (for TPG A, B and C), and are open to revision based on priorities in national action plans

National action plans

- 1 April deadline for national implementation action plans
 - Boost implementation of Bologna commitments and address implementation gaps
 - Help member countries to plan and coordinate actions
 - Increase transparency and help knowledge sharing
- Tool for the TPGs to plan their activities (key commitments and social dimension)
- Secretariat will publish national action plans in the EHEA website and follows up their submission
